AMENDED ADVISORY AGREEMENT

APPEAR

This Commercial Loan Portfolio Servicing Agreement ("Agreement"), entered into this March 7, 2011, between the MUNICIPALITY OF SAN JUAN, (herein after referred to as the MUNICIPALITY), a governmental entity existing under Law No. 81 August 30, 1991, as amended, known as the Puerto Rico Autonomous Municipalities Act, with employer identification number

represented in this act by its Social Administrative Development Executive Director, Iván Muñiz Cabrero, of legal age, married and resident of Guaynabo, Puerto Rico, as authorized by the Municipality's Executive Order SJ-016, Series 2007-2008, with mailing address, P O Box 9024100, San Juan, P.R. 00902-4100, and **COMMERCIAL EQUIPMENT FINANCE, INC.**, a for-profit corporation organized under the laws of the Commonwealth of Puerto Rico, employer identification , herein "CEFI" or "THE SERVICER", with address at Bori St. #1608, La Electrónica Bldg, Suite 209 San Juan, PR 00927.

Both parties reaffirmed their personal circumstances, before these, and ensure that they have the power, standing and authorization necessary to sign this Agreement in the status that they do, and are willing to demonstrate where and when needed, in virtue of what they freely and voluntarily, herein:

WIINESSEIH:

WHEREAS, THE MUNICIPALITY is authorized in accordance to Articles 2.001(n) and 3.009(r) of Law Num. 81 of August 30, 1991, as amended, known as "Ley de Municipios Autónomos" to enter into agreements for professional services;

WHEREAS, The Servicer subscribed a commercial loan portfolio management services agreement number 2011-001913 that was properly registered before the Office of the Comptroller of Puerto Rico, in accordance with Regulation Number 33 (Registry of Contracts, Related Scriptures and Documents and Shipment of Copies to the Office of the Comptroller of Puerto Rico), in accordance to Law Num. 18 of October 30, as amended.

WHEREAS, THE MUNICIPALITY desires to retain THE Servicer as its commercial loan portfolio manager.

WHEREAS, both parties decide to amend the Agreement in order expand the period of the contract.

WHEREAS, both parts have agreed to celebrate this contract of professional services subject to the following:

SCOPE OF SERVICES AND GENERAL PROVISIONS

- 1. The fourth clause of the Contract reforms so that it reads the following:
 - 4. Term of Agreement

4.1 <u>Initial Term and Renewals</u>. This Agreement shall commence on the Effective Date and shall continue <u>for a period of two (2) consecutive years until March 7th, 2013</u> Thereafter, the Parties may, by mutual agreement, renew or amend this agreement to extend its effectiveness under the same or newly negotiated terms and conditions, pursuant to applicable law and regulation. Notwithstanding the foregoing, the new term(s), if any, are subject to the same notification and recording strictures of the Office of the Comptroller for the Commonwealth of Puerto Rico.

With exception to the clause amended here, the other clauses and conditions of Agreement 2011-001913 will remain unchanged, subject to such terms and conditions. The amendments contemplated here constitute the entire understanding of the Parties concerning the subject matter correspondence and understanding between the Parties.

IN WITNESS WHEREOF, each of the Parties has caused its respective duly authorized representative to execute this Agreement as of the date first written above.
